Introduction

As a signatory to the Food and Grocery Code of Conduct (**Code**) prescribed under the *Competition and Consumer Act 2010* (Cth), ALDI Stores (A Limited Partnership) ABN 90 196 565 019 (**ALDI**) is required under the *Competition and Consumer (Industry Codes – Food and Grocery) Regulation 2015* (**Regulation**) to appoint a Code Arbiter in relation to the Code.

On 3 October 2020, when the amendments to the Code came into effect, I was appointed by ALDI as its Code Arbiter.

Time frame

The Code Arbiter for ALDI is required to prepare the report and give copies to ALDI, the Australian Competition and Consumer Commission (ACCC) and the Independent Reviewer within 30 business days after the end of each financial year.
